The above regulations require that charges shall be payable to the Local Authority in respect of submissions for approval under the Building Regulations and the subsequent inspection of works. The actual charges payable are shown in the following tables and are dependent on the type of work and/or its total estimated cost. In the unlikely event that the scheme results in extra work being undertaken by the authority above that anticipated then supplementary charges may be incurred.

All fees are subject to VAT at the appropriate rate, except the Regularisation charge. Full Plan Applications: The plan charge and inspection charge are listed in the following tables.

Building Notice Applications: The Building Notice procedure is more complex to ensure compliance with the Building Regulations and the resultant additional cost is reflected in the tables.

Reversion Charge: These charges will be individually determined.

Regularisation Charge: Contact 01268 208026 to discuss appropriate fees

Reductions: The reductions indicated on tables A and B apply where controlled electrical installations form part of the works and these are to be carried out by a suitably qualified Part P registered electrician resulting in a satisfactory Design, Installation and Test Certificate. If these reductions are claimed and a self certifying electrician is not subsequently employed you will be invoiced for supplementary charges equivalent to the discount.

Multiple work reductions: Where the proposed works consist of more than one element then the appropriate fee is calculated by paying the full amount for the most expensive element and only **50% for the other applicable elements.**

Total Estimated cost: This means a reasonable estimate that would be charged by a professional builder, but excluding professional fees and vat.

Instalments: In some cases of large developments the charge may be paid by instalments: contact the number below.

Where work relates to more than one fee category, cost exceeds £100,000 or where standard fees are not applicable, please contact the number below to confirm appropriate fee.
